You are hereby required in the name of the Commonwealth of Massachusetts to notify and warn qualified voters of said Town of Wrentham to assemble at the King Philip Regional High School, 201 Franklin Street Wrentham, MA 02093 at 7:00PM on Monday, October 21, 2024 then and there to act on the following articles:

Article 1: Volunteer of the Year

For the Select Board to recognize the Town of Wrentham's 2024 Volunteer(s) of the year, or take any other action relative thereto. (Select Board)

Article 2: Fiscal Year 2025 Budget Amendments

To see if the Town will vote to raise and appropriate, appropriate by transfer from available funds in the treasury, or appropriate by transfer from funds previously appropriated to other accounts, a sum of money to supplement the current Fiscal Year 2025 operating budgets, or take any other action relative thereto. (Finance Committee)

Article 3: Prior Year Bills

To see what action the Town will take with regard to unpaid bills outstanding, or overdrafts from prior year(s), to vote to raise and appropriate, to appropriate by transfer from unappropriated available funds in the treasury, or appropriate by transfer from funds previously appropriated to other accounts, a sum of money for the same, or take any other action relative thereto. (Finance Committee)

Article 4: Capital Budget

To see if the Town will vote to raise and appropriate, appropriate by transfer from available funds in the treasury, appropriate by borrowing, or appropriate by transfer from funds previously appropriated to other accounts, a sum of money to fund capital items, or take any other action relative thereto. (Finance Committee)

Article 5: Establishment of Electric Vehicle (EV) Charging Station Revolving Account To see if the Town will vote to amend Chapter 18-7, paragraph E of the authorized Revolving Funds, of the Wrentham Town Code by adding one revolving fund to the table as follows:

Article 6: Ground Penetrating Radar

To see if the Town will vote to appropriate the sum of \$15,000 from the Historical Reserve account of the Community Preservation Fund, for the purpose of purchasing a ground penetrating radar to identify historical unmarked burial areas in Wrentham Cemeteries. Funds appropriated must be used by December 31, 2026 or will be returned to their source, and no longer be available for expenditure on this project; or take any other action related thereto. (Community Preservation Committee)

Article 7: Rochambeau Encampment Signage

To see if the Town will vote to appropriate the sum of \$3,500 from the Historical Reserve account of the Community Preservation Fund, for the purpose of installing signage marking the site of the Rochambeau encampment on the grounds of the King Philip Regional High School. Funds appropriated must be used by December 31, 2026 or will be returned to their source, and no longer be available for expenditure on this project; or take any other action related thereto. (Community Preservation Committee)

Article 8: Conservation and Recreation Land Acquisition Fund
To see if the Town will vote to appropriate the sum of \$200,000 from the Open Space
and Recreation Reserve account and/or the Budgeted Reserve account of the
Community Preservation Fund, for the purpose of further funding the Conservation and
Recreation Land Acquisition Fund that was established in 2022. Acquisitions must
adhere to CPA land acquisition rules at the time of the acquisition, and a conservation
restriction will need to be put in place for the acquired land. Funds appropriated must be
used by December 31, 2036 or will be returned to their source, and no longer be

available for expenditure on this project; or take any other action related thereto. (Community Preservation Committee)

Article 9: Phase II – Mirror Lake Core & Sediment Study
To see if the Town will vote to appropriate the sum of \$208,250 from the Budgeted
Reserve account and/or the Undesignated Fund Balance of the Community
Preservation Fund, for the purpose of funding a Phase II core and sediment study of
Mirror Lake to determine the feasibility of future dredging activities to preserve this open
space. Funds appropriated must be used by December 31, 2026 or will be returned to
their source, and no longer be available for expenditure on this project; or take any
other action related thereto. (Community Preservation Committee)

Article 10: Annual Town Report Cataloguing

To see if the Town will vote to appropriate the sum of \$33,750 from the Historical Reserve account of the Community Preservation Fund, for the purpose of preserving and cataloguing Town Annual Reports. Funds appropriated must be used by December 31, 2026 or will be returned to their source, and no longer be available for expenditure on this project; or take any other action related thereto. (Community Preservation Committee)

Article 11: Old Fiske Museum Facility Assessment

To see if the Town will vote to appropriate the sum of \$8,000 from the Historical Reserve account of the Community Preservation Fund, for the purpose of conducting a facility assessment of the Old Fiske Library. Funds appropriated must be used by December 31, 2026 or will be returned to their source, and no longer be available for expenditure on this project; or take any other action related thereto. (Community Preservation Committee)
